W.H.O. has declared the Novel Corona Virus (COVID-19) pandemic as Public Health Emergency of International Concern (PHEIC). To mitigate the risk of COVID-19, contact/gathering of people in large numbers need to be restricted. The prevailing COVID-19 pandemic is posing a threat to public Health, It is necessary to take steps to prevent its spread in Kaithal District

Therefore , it is essential that opening of all Gym's, Yoga Halls, Dance Academy and Swimming Pool where a large number of peoples are likely to gather at the same time should be restricted to prevent such danger to human health and safety in view of above Novel Corona Virus (COVID-19) pandemic.


And whereas The District Consultative Committee are satisfied that immediate measures are needed to be taken for prevention of such danger of human health and safety relating to General Public and decision has been taken in the meeting of The District Consultative Committee is held on 27-04-2021 at 11-00 A.M. that all Gym's, Yoga Halls, Dance Academy and Swimming Pool will be closed for human health and safety.

Now, therefore, In exercise of powers conferred under Disaster Management Act, 2005, I, Sujan Singh, I.A.S., District Magistrate-Cum-Chairperson, District Disaster management Authority, Kaithal do hereby order that all Gym's, Yoga Halls, Dance Academy and Swimming Pool where a large number of peoples are likely to gather at the same time and which is operating within the district Kaithal shall remain closed **With immediate effect till further orders.**

Superintendent of Police, Kaithal, All Sub Divisional Magistrate's, District Municipal Commissioner, Kaithal, Concerned Incident Commanders-Cum-Tehsildar/Naib-Tehsildar, Executive Officer, Municipal Council, Kaithal and Concerned Secretary, Municipal Committee shall be responsible for the compliance of the above orders.

In view of the emergent situation and shortage of time, this order is being passed ex-parte. Any person violating these measures will be proceeded as per the provisions of Section 51 to 60 of the Disaster Management Act, 2005, beside legal action under Section 188 of the Indian Penal Code, and other provisions as applicable. Extracts of these penal provisions are at Annexure-I


D.I.O., N.I.C., Kaithal and District Information & Public Relations Officer, Kaithal shall give wide publicity of this order within the District Kaithal through news paper, social media, print and electronic media.
