

ORDER UNDER SECTION 144 OF THE CODE OF CRIMINAL PROCEDURE, 1973

Whereas it has been made me appear that there is likelihood of causing tension, annoyance and disturbance of public peace and tranquility within the limit of Examination centers on account of **Written Examination of Secondary/Senior Secondary compartment etc which are to be held from dated 18-08-2021 to 01-09-2021** in the Various centers of the district being conducted by Board of School Education Haryana, Bhawani.

Whereas it has been made me appear that the gathering of five or more persons is likely to cause obstruction in the maintenance of peace and tranquility within the area of about 200 meters around the all Examination centers in Kaithal District.

Now, therefore, in exercise of the powers vested in me by virtue of Section 144 of Code of Criminal Procedure, 1973. **I, Pradeep Dahiya, I.A.S., District Magistrate, Kaithal** do hereby prohibit the gathering of five or more persons in the area of 200 meters around the Examination centers in Kaithal District from **18-08-2021 to 01-09-2021** during exam date and hours. Photostate business is banned only on the same dates in the area of 200 meters around the Examination centers.

This order shall not apply to the Police and other public servants on duty. In view of the emergent situation of shortage of time, this order is being passed ex-parte and is being addressed to the public in general.

This order shall be promulgated within the limits of Examination centers in Kaithal District by beat of drum, by announcement, through the publicity Van of public Relation Department, by fixing of the copies of this order on Notice Boards of the Examination centers, Sub Divisional and Tehsil Courts and public places as well as the Police Stations.

For the violation of the aforesaid order, if any person found guilty, he will be liable for punishment under section, 188 of the Indian Penal Code.
