

**ORDER UNDER SECTION 144 OF THE CODE OF CRIMINAL PROCEDURE, 1973**

Whereas it has been made me appear that there can be likelihood of causing tension, annoyance and disturbance of public peace and tranquility in orders of celebration of Janmashtmi Utsav due to Covid-19 P endemic in the Various temples of the district Kaithal.

Whereas it has been made me appear that the gathering of five or more persons can cause obstruction in the maintenance of peace and tranquility within the area of about 200 meters around all the temples in Kaithal District.



Now, therefore, in exercise of the powers vested in me by virtue of Section 144 of Code of Criminal Procedure, 1973. **I, Pradeep Dahiya, I.A.S., District Magistrate, Kaithal** do hereby prohibit the gathering of five or more persons in the area of 200 meters around all the temples in Kaithal District for **30-08-2021**

This order shall not apply to the Police and other public servants on duty. In view of the emergent situation of shortage of time, this order is being passed ex-parte and is being addressed to the public in general.

This order shall promulgated in Kaithal District by beat of drum, by announcement through the publicity Van of Public Relation Department, by fixing of the copies of this order on Notice Boards of all govt. offices and temples, Sub Divisional and Tehsil Courts and public places as well as on the Police Stations.

For the violation of the afforesaid order, if any person found guilty, he will be liable for punishment under section, 188 of the Indian Penal Code.
