ORDERS UNDER SECTION 144 OF THE CODE OF CRIMINAL PROCEDURE


Porompat, the 22nd March, 2020.

1. Whereas, the State Government has been taking up all possible measures to prevent and contain the spread of CORONA virus disease in the State;
2. Whereas, there has been substantial increase in the number of persons confirmed to have been infected by the Novel Corona Virus COVID-19 in India in the last couple of days and immediate precautionary measures need to be taken up to prevent further spread of COVID-19;
3. Whereas, it has been expedient to issue prohibitory orders to reduce/stop mass gathering with the view to prevent/ minimize further spread of COVID-19;
4. Whereas, there is emergency and circumstances that do not permit the serving in due time of a notice upon the public, this order is passed ex-parte under Sub-section 2 of Section 144 Cr. P.C, 1973 and is directed to the public in general;
5. Now, therefore, I, **Dr. Rangitabali Waikhom**, District Magistrate, Imphal East District, Manipur in exercise of the powers conferred under Section 144 of Cr. P. C., 1973, do hereby prohibit the following activities in the area which is described in the schedule given below **with immediate effect till 31/03/2020.**
 - i. Assembly of 4(four) or more persons outside their residence
 - ii. All social/customary/religious/political and any other gatherings
6. This order shall not apply to the agencies of the Govt. involved in maintenance of law & order and essential services.
