No. DC(IE)/COVID-19/2020/1829 In furtherance to the discontinuation of HRD Academy (Ghari, Imphal West) as Transit Quarantine Centre for air passengers w.e.f. 31st October, 2020 vide Govt. letter No. 31/64/2020-M dated 21st October, 2020, it is hereby informed to all the concerned particularly flight passengers of Imphal East District that **e-pass shall be mandatory for them w.e.f. 31-10-2020**. The passengers may log in to <https://imphaleast.nic.in/services/> for availing e-pass at least 1 (one) day prior to the date of arrival.

If, due to unavoidable circumstances, any air passenger of Imphal East district/passenger who will be heading to Imphal East District could not apply for e-pass in time, they may do so after arrival at the arrival hall at the same website mentioned above and should proceed to the District Testing Centre mentioned in the e-pass for mandatory COVID-19 testing.


