**ORDERS UNDER THE ARMS ACT**

No. DM(IE)/5/7/Deposit/2011/1656 Whereas, Home Department, Govt. of Manipur vide Letter No. 771/2021-H(Guns) dated, 25<sup>th</sup> October, 2021 has advised all District Magistrates of Manipur to issue suitable notifications to cause deposit of all licensed guns to the Police Stations concerned at the earliest for the maintenance of law and order in the context of the ensuing State Legislative Assembly General Elections, 2022;


2. Whereas, the undersigned is fully convinced and satisfied that there is sufficient ground for passing an appropriate order thereby directing the arms licensed holder under the revenue jurisdiction of Imphal East District to deposit their licensed arms at the nearest Police Station;

3. Now, therefore, I, Khumanthem Diana Devi, IAS, District Magistrate, Imphal East District, in exercise of the powers conferred under the Arms Rules, 2016 and Arms Act, 1959, do hereby order all arms license holders within the revenue jurisdiction of Imphal East District to deposit their licensed arms at the nearest Police Station concerned with immediate effect;

**Schedule: The whole of the area of the Revenue District of Imphal East**

4. Any individual who desires to appeal against this order may submit his/her written justification for retaining his/her license arms to the Office of the undersigned during office hours on or before 3.00 pm of 10.11.2021 on all working days.

5. Failing which necessary action shall be initiated against the defaulters which includes cancellation of arms license under relevant provision of Arms Act, 1959 & Rules, 2016.
