विधि सल्लागार-नि-सह सचिव, विधि व न्याय विभाग, मंत्रालय, मंबई-32 यांचेकडील अर्धशासकीय पत्र क्र एपीपी-4217/प्र.क्र.11-का.14. दिनांक 14/02/2017 चे अन्वये जिल्हा व सत्र न्यायालयात मुलांच्या हक्क संरक्षण अधिनियम 2005 अंतर्गत प्रकरणे हाताळण्यासाठी विशेष सरकारी अभियोक्ता या पदासाठी धुळे जिल्हयाकरीता 02 पदे तात्पुरत्या स्वरूपात भरावयाची असून, पात्र उमेदवारांकडून विहित नमुन्यातील अर्ज मागविले आहेत.

2. या नियुक्त्या निव्वळ तात्पुरत्या स्वरूपात करण्यात येतील व सदर नियुक्त्या मुलांचे हक्क संरक्षण अधिनियम 2005 च्या कलम 26 फौजदारी प्रक्रिया संहिता 1973 च्या कलम 24 (3) व महाराष्ट्र विधि अधिकारी नियम, 1984 च्या नियम क्र 11, 12, व 13 यामधील तरतुदींच्या अधीन असतील. सदर पदावर नियुक्तीसाठी पात्र महिला उमेदवारास प्राधान्य राहिल. या नियुक्त्या पुर्वोक्त नियमामधील तरतुदींच्या अधीन राहून कोणत्याही वेळी कोणतीही पुर्वसुचना न देता संपुष्टात आणण्याचा अधिकार शासन राखून ठेवित आहे.

### 3. नियुक्तीसाठी पात्रतेचे निकष

- 1) अर्जदार भारताचा नागरीक असावा.
- 2) अर्जदार कोणत्याही मान्यताप्राप्त विद्यापीठाचा विधि पदवीधर असावा आणि त्याने बार कौन्सिल ऑफ महाराष्ट्र आणि गोवा यांचेकडे वकील म्हणून नोंदणी केलेली असावी.
- 3) जाहिरातीच्या दिनांकास अर्जदाराचे वय 55 वर्षांहून अधिक असू नये.
- 4) जाहिरातीच्या दिनांकास अर्जदारास वकिली व्यवसायाचा किमान 7 वर्षांचा अनुभव असणे आवश्यक आहे.

4. उपरोक्त पदांसाठी इच्छुक असलेल्या उमेदवारांनी त्यांचे अर्ज या सूचनेसोबत जोडलेल्या विहित नमुन्यात भरून ते जिल्हाधिकारी व जिल्हादंडाधिकारी धुळे यांच्या नावाने अग्रेषित करावेत व परिपूर्ण भरलेले विहित नमुन्यातील अर्ज जिल्हाधिकारी कार्यालय, धुळे या ठिकाणी समक्ष दाखल करावेत.

5. अर्ज सादर करण्याचा अंतिम दिनांक 27/07/2018 असा असून या दिनांकापर्यंत कार्यालयीन वेळेत प्राप्त झालेले अर्ज स्विकारण्यात येतील. विहित मुदतीनंतर प्राप्त झालेल्या त्याचप्रमाणे, अपुर्ण व अस्पष्ट अर्जांचा विचार केला जाणार नाही.

6. नियुक्तीसाठी पात्रतेच्या निकषांच्या अनुषंगाने अर्जदाराने आपल्या अर्जासोबत आवश्यक त्या कागदपत्रांच्या / प्रमाणपत्रांच्या साक्षांकीत प्रती जोडणे आवश्यक आहे.


7. सदर नियुक्त्या उमेदवारांच्या मुलाखती घेऊन केल्या जाणार असल्याने अर्जांच्या छाननीअंती मुलाखतीसाठी पात्र उमेदवारांची संख्या मर्यादीत करण्याचा अधिकार शासन राखून ठेवित आहे.



- 3) Applicant must not be more than 55 years of age on the date of advertisement.
- 4) Applicant must have at least 7 years of practice as an Advocate on the date of advertisement.

The application should be addressed to the Collector and District Magistrate Dhule. The application duly filled in must be submitted to the Collector and District Magistrate Office Dhule by **hand delivery**.

6. The applications must be accompanied by attested photocopies of documents /testimonials, with regard to eligibility criteria as mentioned in Para 3 .


7. The government of Maharashtra reserves the right to shortlist the number of eligible candidates for interview after scrutiny of the applications.

8. Canvassing in any form whatsoever by any candidate shall entail disqualification.



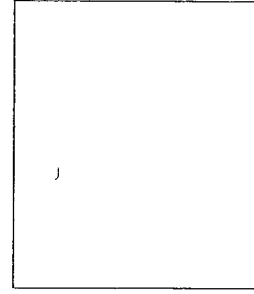
