Subject: Curfew / restrictions in District Samba under Section 144 of Cr.P.C. from 7 PM to 7 AM.

ORDER

Whereas, this office had issued one order No. DMS/2020/Covid-19/1057-67 dated 2-5-2020, whereby restrictions under Section 144 of Cr.P.C. imposed vide order No. DMS/JC/2020/Covid-19/519-30 dated: 15/04/2020, now further extended upto 17-05-2020. And all the restrictions and relaxations were also extended upto the same date i.e. 17-05-2020.

Whereas, the Ministry of Home Affairs, Government of India has issued order vide No. 40-3/2020-DM-I(A) dated 01.05.2020 to take effective measures to prevent the spread of COVID-19 under Disaster Management Act, 2005 for further extension of lockdown period upto 17.05.2020;

Whereas, Chairperson of the State Executive Committee, Department of Disaster Management Relief Rehabilitation and Reconstruction Civil Sectt. J&K Jammu vide his order No. 49-JK (DMRRR) of 2020 dated 3-5-2020, has issued further restriction/guidelines on lockdown measures for effective containment of COVID - 19 w.e.f. 4th. May 2020 till further orders;

Therefore, in view of above and instructions issued by Chairperson of the State Executive Committee, Department of Disaster Management Relief Rehabilitation and Reconstruction Civil Sectt. J&K Jammu as mentioned above for containment of COVID-19 epidemic, **I, Rohit Khajuria, KAS, District Magistrate Samba in terms of the powers conferred upon me under Section 144 of the Criminal Procedure code, 1973, do hereby order that :**

- (i) **There shall be no movement of Individuals for all non-essential activities between 7.00 PM to 7.00 AM.**
- (ii) **There shall be no movement of Persons above 65 years of age, persons and with co-morbidities, pregnant women, and Children below the age of 10 years, shall stay at home, except for meeting essential requirements or for health purposes.**
- (iii) **All instructions relating to safety, health precautions, social distancing etc. shall continue to apply.**

The above restrictions shall remain enforce in District Samba during the lock down period till 17-05-2020.
