Subject: Restrictions in District Samba under Section 144 of Cr.P.C.

ORDER

Whereas, this office had issued an order No. DMS/2020/COVID-19/1057-67, dated: 02-05-2020, whereby restrictions were imposed under Section 144 of Cr.P.C on the movement of 3 or more persons in District Samba upto 17th of May, 2020.

Whereas, this order was in continuation to various orders issued from time to time since 23-03-2020, these orders were issued vide Nos. DMS/JC/2019-20/1121-32, dated: 23-03-2020, DMS/JC/2019-20/1133-44, dated: 25-03-2020, DMS/JC/2020/Covid-19/519-30, dated: 15-04-2020 and DMS/Misc/Covid-19/1123-33, dated: 04-05-2020.

Whereas, Curfew was also imposed from 7 PM to 7 AM through above order dated: 04-05-2020. Now, in light of the order issued by Ministry of Home Affairs, Government of India vide No. 40-3/2020-DM-I(A), dated: 17-05-2020 and the Chairperson, State Executive Committee, Department of Disaster Management, Relief, Rehabilitation & Reconstruction, Government of J&K has issued order No. 53-JK (DMRRR) of 2020, dated: 17-05-2020, whereby instructions have been given that guidelines / instructions issued vide order No. 49-JK-(DMRRR) of 2020, dated: 03-05-2020, shall continue till 19-05-2020.

Therefore, in view of above and instructions issued by the Chief Secretary (Chairperson) State Executive Committee, Department of Disaster Management, Relief, Rehabilitation & Reconstruction, Government of J&K, **I, Rohit Khajuria, KAS, District Magistrate, Samba in terms of the powers conferred upon me under Section 144 of the Criminal Procedure Code, 1973, do hereby order that lockdown period shall be extended upto 19-05-2020, in District Samba and all other restrictions imposed by the District Administration Samba, including the night Curfew from 7 PM to 7 AM shall remain in force till 19-05-2020.**
