Subject: Restrictions in District Samba under Section 144 Cr.P.C.

**ORDER**

Whereas, an order was issued by this office vide order No. DMS/JC/2020/10-21, dated 19.05.2020, wherein Section 144 of Cr.P.C of 1973, was extended upto 31.05.2020, in the district and vide same order the night curfew from 07:00 PM to 07:00 AM was also imposed in Samba District;

Whereas, another order was issued vide order No. DMS/Misc/2020/Covid-19/3109-20, dated 01.06.2020, whereby lockdown period under Section 144 of Cr.P.C of 1973, was also extended upto 08.06.2020, and the restrictions/relaxations were also extended upto the same date i.e. 08.06.2020;

Whereas, the Chairperson, State Executive committee, Department of Disaster Management, Relief, Rehabilitation & Reconstruction, Government of J&K has issued order No. 59-JK(DMRRR) of 2020, dated 07.06.2020, wherein Samba District has been categorized in Orange Zone;

Whereas, the Chairperson, State Executive committee, Department of Disaster Management, Relief, Rehabilitation & Reconstruction, Government of J&K has issued order No. 61-JK(DMRRR) of 2020 dated 07.06.2020, whereby guidelines/instructions for regulating activities in the UT of Jammu and Kashmir for Unlock-1 w.e.f. 08.06.2020 have been issued;

Whereas, instructions and guidelines mentioned in this SOP with respect to Orange Zone shall also be implemented in Samba District;

Therefore, in view of above, I, **Rohit Khajuria, KAS, District Magistrate, Samba** in terms of the powers conferred upon me under Section 144 of the Criminal Procedure Code, 1973, do hereby order that extended period of lockdown (Unlock-1) is enforced till further orders in district Samba by invoking Section 144 of Cr.P.C. w.e.f. 09.06.2020 and SOPs imposed in the Orange Zone including the night curfew from 08:00 PM to 05:00 AM shall also remain in force till further orders.
