Walk in Interview

For hiring of pharmacists under Pradhan Mantri Bhartiya Jan Aushadi Kendras at District Hospital Samba, AH Ghagwal, EH Vijaypur & PHC Purmandal.

District Health Society, Samba is going to establish Pradhan Mantri Bhartiya Jan Aushadi Kendra at District Hospital Samba, AH Ghagwal, EH Vijaypur & PHC Purmandal with the objective to make available quality generic medicines at affordable price to all, particularly the poor & disadvantaged, through exclusive outlets Pradhan Mantri Bhartiya Jan Aushadi Kendras so as to reduce pocket expenses in healthcare. In this regard District Health Society Samba intends to hire Registered Pharmacists from J&K Pharmacy Council under the provision of Pharmacy Act-1940 from District Samba to work on profit sharing basis at Pradhan Mantri Bhartiya Jan Aushadi Kendra District Hospital Samba, AH Ghagwal, EH Vijapur & PHC Purmandal. In this regard Walk in Interviews will be held on 15-02-2021 at 11AM in the office of Chief Medical Officer, District Administrative Complex, Nandani Hills Samba. Eligibility criteria & Terms/conditions are as under:-

Candidates Required:- Total 08 candidates, 02 Each for DH Samba/AH Ghagwal/EH Vijaypur & PHC Purmandal.

Eligible Criteria:-


1. Applicant should be permanent resident of District Samba.
2. Maximum age limit is 40 years (candidates more in age shall be preferred over younger candidates.)
3. The candidate shall be a Registered Pharmacist from J&K Pharmacy Council under the provision of Pharmacy Act-1940. Preference shall be given to the candidate having Diploma in Pharmacy or higher related qualification from recognized institution.
4. He/she shall have working knowledge of operating computer for billing purpose.
5. He/She shall be unemployed for which he/she has to give an undertaking to this effect on stamp paper duly attested by 1st Class Judicial Magistrate.

Terms & Conditions:-

1. PMBJAK shall be run 24X7 basis under the supervision of Medical Superintendent District/ Concerned Block Medical Officer.
2. Engagement of Pharmacists in PMBJAK is a temporary arrangement for three years on performance basis and shall not confirm any right for his/her permanent absorption/regularization in the Department & can be terminated any time without notice.
3. Out of total 20% margin on MRP of each drug as per guidelines registered pharmacists shall be Provided 15% (each Pharmacist=7.5%) of margin on MRP of each drug & rest of 5% of the margin Shall go to the Hospital Development fund of concerned institution.
4. Only medicines supplied by BPPI should be sold at PMBJAK.
5. All the billing should be done by using software provided by BPPI.

6. The selected candidates shall execute an agreement with the department through Medical Superintendent & concerned Block Medical Officer attested by 1st Class Judicial Magistrate, that He/she will abide by all the terms & conditions as laid BY THE Department & shall work under the Supervision of concerned DDO & shall not claim any regular appointment/regularization in the Department in lieu of this agreement.
7. No TA/ DA will be paid for attending the interview.
