**ORDER**


Whereas, vide this office order No. DMS/JC/21-22/195-206, dated: 24-04-2021, Andrar Mandi, Gurha Slathia, Tehsil Vijaypur was declared as Micro Containment Zone, as 5 Corona positive cases was confirmed in the said area;

Whereas, the entire area of Andrar Mandi, Gurha Slathia, Tehsil Vijaypur was cordoned and no inward and outward movements were allowed;

Whereas, as reported by Chief Medical Officer, Samba vide his office letter No. CMO/S/NHM/258, dated: 04-06-2021, that the contact tracing and sampling of the designated containment zone have been completed and further no positive case was confirmed in the said area for the last 15 days.

In view of the above, Andrar Mandi, Gurha Slathia, Tehsil Vijaypur is hereby de-notified from the Micro Containment Zone "Hot-Spot" with effect from 04-06-2021. The restrictions and exemptions as applied in other areas of the Samba District shall also apply in Andrar Mandi, Gurha Slathia, Tehsil Vijaypur;

Further, the people of the area are directed to take all precautions such as social distancing, wearing mask and other protocols / directions issued by the District Administration from time to time.
