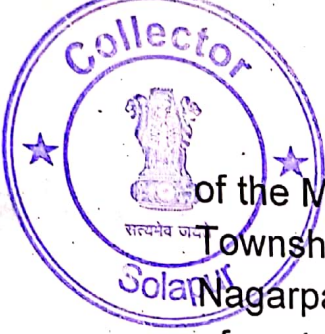
1. In exercise of the powers conferred on me by Order No.SEC/NP-2020/P.K.1-A/k-6 dated 6.2.2020 of the State Election Commissioner, Maharashtra, the Collector of Solapur district, hereby proposes to make the following draft order under sub-section (1) of section 10 of the Maharashtra Municipal Councils, Nagar Panchayats and Industrial Townships Act, 1965 (Mah. XL of 1965) (hereinafter referred to as the said Act) to fix for the Madha Nagarpanchayat, the number and the extent of the wards into which the said Nagarpanchayat area shall be divided and to specify the wards reserved for Scheduled Castes, Scheduled Tribes, Backward Class of Citizens and Women (including women belonging to the Scheduled Castes, the Scheduled Tribes and the Backward Class of Citizens), as the case may be, as shown in the Schedule to this Order.

2. The said draft Order is hereby published as required by the provision to sub-section(1) of section 10 of the said Act for the information of all the residents of the Madha Nagarpachayat and notice is hereby given that the said draft will be taken into consideration by the Collector, Solapur after 11/11/2021

3. All persons who desire to entertain any objections to the said draft, should submit the same to The Collector, Solapur in writing with reasons therefore on or before 16/11/2021 Objections received thereafter will not be considered.(The place for submitting objection Madha Nagarpanchyat Madha)

### DRAFT ORDER

1. WHEREAS, the Divisional Commissioner Pune Division will (Maharashtra Government Gazette) as per SEC letter No.SEC/NP-2021/PK-03/Ka-06 dated 09.11.2011 under sub-section (2) of section 9



of the Maharashtra Municipal Councils, Nagar Panchayats and Industrial Townships Act, 1965 (Mah. XL of 1965) will fix for the Madha Nagarpanchayat the number of councilors to be elected and the number of seats to be reserved for the Scheduled Castes, Scheduled Tribes and Backward Class of Citizens and Women (including the number of seats reserved for women belonging to the Scheduled Castes the Scheduled Tribes and Backward Class of Citizens), as shown below.as per proposed of Chief Officer

- 1) The number of Councillors to be elected =17
- 2) The number of seats to be reserved
  - a) for the Scheduled Castes =04
  - b) for the Scheduled Tribes =00
  - c) for the Backward Class of Citizens =04
- 3) The total number of seats to be reserved for Women (including the number of seats reserved for women belonging to the Scheduled Castes, Scheduled Tribes and Backward Class of citizens) =09
- 4) Out of seats at serial number 3, the number of seats reserved for women belonging to the Scheduled Castes, Scheduled Tribes and Backward Class of citizens from amongst the seats reserved for Scheduled Castes, Scheduled Tribes and Backward Class of citizens) as shown in item at serial number 2(a) , (b) and (c), respectively, are as under
  - a) for the Scheduled Castes =02
  - b) for the Scheduled Tribes =00
  - c) for the Backward Class of Citizens =02
- 5) Number of seats reserved for women as General category (number of seats at serial number 3 minus number of seats at serial number 4) = 05
