Whereas, Director Urban Local Bodies, Jammu vide Communication No. DULBJ/P&S/2018-19/16894-98 dated 01-12-2018 has placed a formal indent for transfer of State land measuring 10 Kanals situated at village Dharmound for setting up of Solid Waste Management Plant/Dumping Yard for Municipal Committee Ramban.

Whereas, a land identification team comprising of Divisional Officer State Pollution Control Board Ramban, Tehsildar Batote and Executive Officer Municipal Committee Batote has identified the said land at Dharmound and confirmed the same vide their Communication No. SPCB/RDJ/MSW/19/4228-33 dated 14-05-2019.

Whereas, site has been approved and NOC issued by the State Pollution Control Board Ramban vide Communication No. SPCB/RDJ/MSW/19/4228-33 dated 14-05-2019.

Whereas, the Revenue papers of the site were prepared and the case was submitted to Divisional Commissioner Jammu for necessary action. Divisional Commissioner Jammu vide Communication No. 502/3485/SWMP/Batote/Rbn/19/425-26 dated 04-05-2019 directed this office to proceed in the case as per the provisions of Govt. Order no. 30-Rev(S) of 2019 dated 05-03-2019.

Now, therefore, in terms of powers vested with me vide Government Order No. 30-Rev(S) of 2019 dated 05-03-2019, sanction is hereby accorded for transfer of State land measuring 10 Kanals (Free from encumbrances) under Khasra no. 13 at village Dharmound Tehsil Batote District Ramban to Housing & Urban Development Department, Government of Jammu & Kashmir, through Director, Urban Local Bodies, Jammu (Municipal Committee, Batote) forthwith under Solid Waste Management.
