Sub: COVID-19 Management- inter District public passenger transport thereof.

ORDER

Whereas, COVID-19 has been declared as global pandemic by World Health Organization (WHO) affecting several Countries of the world including India;

Whereas, all type of Public transport was banned through various SOPs in UT of J&K during the COVID-19;

Whereas, as per SOP issued Vide Government Order No: 74-JK (DMRRR) of 2020 dated: 04.08.2020 under which the inter District public transport stands allowed subject to various conditions;

Now, therefore in view of the above mentioned facts and in the interest of safety and well being of general public at large, I Nazim Zai Khan, KAS District Magistrate Ramban in exercise of the powers vested in me under Section 144 Cr.P.C, Section 34 of National Disaster Management Act, 2005 and in accordance with Section 2 of the Epidemic Diseases Act, 1897 do hereby order that inter District public passenger transport vehicles running of routes (buses/mini buses and maxi cabs) is allowed to operate in territorial jurisdiction of District Ramban except routes of containment/Red Zones declared by this office subject to the following conditions:

- a) Inter District public passenger transport running of routes (buses, mini buses and Maxi cabs) is permitted with upto 2/3rd seating capacity for buses and upto 50% seating capacity in mini buses/maxi cabs on routes to be notified by the ARTO Ramban.
- b) That wearing of face mask will be mandatory for passengers and Driver will be responsible to ensure the same.
- c) Intra District movement of individuals in vehicles is allowed with a maximum of 02 passengers besides the driver in four wheeler and with no pillion rider in case of two wheelers with passes from competent authority.
- d) That bus/mini bus/maxi cab operator shall enhance 30% of the existing fare in respect of all the routes within the District. .ARTO Ramban ensure vide publicity of approved fares of all routes of District Ramban.

This order shall remain in-force with effect from 24.08.2020 till further orders.

In view of the emergent nature of the order, it is not possible to serve it individually and is addressed to the public of Ramban District in general. It shall be circulated in print, electronic and social media and through the medium of loud speakers for information of all concerned.
