sub: De-notification of Red/Containment Zone.

ORDER

Whereas, in view of apprehension of spreading/transmission of Corona virus (COVID-19) due to detection of COVID-19 Positive cases in each Village Tehtar, Gund Tehtar, Dooligam, Hala Chamalwas of Tehsil Banihal, Panchayat Neel-A of Tehsil Ramsoo Teligam and Boom Chanderkote of Tehsil Ramban and the said villages were declared as Containment/Red Zones Vide this office Order No: DCR/COVID-19/1669-80 dated: 16.05.2020, DCR/COVID-19/1698-07 dated: 01.06.2020, DCR/COVID-19/2100-09 Dated: 12.06.2020, DCR/COVID-19/2126-36 dated: 16.06.2020, DCR/COVID-19/2557-66 dated: 17.07.2020 and DCR/COVID-19/2701-09 dated: 23.07.2020;

Whereas, these all villages were sealed and all in and out movement was restricted as per SOP issued Vide Govt Order No: 38-JK(DMRRR) of 2020 dated: 14.04.2020;

Whereas, the sampling of vulnerable persons, persons with co-morbidities, persons with above 50 year age, persons with ILI/SARI symptoms has done and none of them were found COVID-19 Positive;

Whereas, random sampling of at least 50% of the total population of the hamlet stands completed and out of them no one has been detected COVID-19 Positive;

Whereas, the guidelines issued Vide Government Order No: 63-JK(DMRRR) of 2020 dated: 24.06.2020 were followed in letter and spirit,

Whereas, after passage of more than 21 days from the date of declaration the said areas as Red Zone, no COVID-19 Positive case have been detected from the said areas;


Whereas, Chief Medical Officer Ramban Vide No: CMO/RBN/1209-12 dated: 04.09.2020 recommended for de-notification of the above said Containment/Red Zones.

Now, therefore, in view of the above mentioned facts as well as in the interest of safety and well being of general public at large, I Nazim Zai Khan, KAS District Magistrate, Ramban in exercise of the powers vested in me under Section 144 Cr.PC National Disaster Management Act, 2005 and Epidemic Diseases Act, 1897 and in light of the Government Order No: 63-JK(DMRRR) of 2020 dated: 24.06.2020 do hereby order that Village Tehtar, Gund Tehtar, Dooligam, Hala Chamalwas of Tehsil Banihal, Panchayat Neel-A of Tehsil Ramsoo Teligam and Boom Chanderkote of Tehsil Ramban are de-notified from Red/Containment Zone.
