Sub: Measures to prevent the spread of Coronavirus- Imposition of restrictions under Section 144 Cr.P.C in the District thereof.

ORDER

Whereas, necessary precautions regarding prevention and control of Coronavirus (COVID-19) infection have already been undertaken by District Administration in coordination with Police and Health department; and

Whereas, COVID-19 has pattern of transmission of rapid rate, in case prescribed prevention protocols including mass gathering and unnecessary movement etc are not strictly followed.

Whereas, as per advisories issued by the Health Authorities to prevent the spread of COVID-19 pandemic and break the transmission chain of the virus, it is necessary to enforce certain restrictions in order to control the spread of the virus in the District.

Now, therefore in view of the above mentioned facts and in the interest of safety and well being of general public at large, I Nazim Zai Khan, KAS District Magistrate Ramban in exercise of the powers vested in me under Section 144 Cr.P.C, Section 34 of National Disaster Management Act, 2005 and in accordance with Section 2 of the Epidemic Diseases Act, 1897 do hereby impose complete ban on movement of individuals for all non-essential activities between 10.00 PM to 05.00 AM in territorial jurisdiction of District Ramban with immediate effect till further orders.

Any violation of this order shall invite action under Indian Penal Code/Disaster Management Act, 2005 and Epidemic Diseases Act, 1897.
