Sub: Measures to prevent the spread of Coronavirus - Imposition of restrictions under Section 144 Cr.P.C in the District thereof.

ORDER

Whereas, necessary precautions regarding prevention and control of Coronavirus (COVID-19) infection have already been undertaken by District Administration in coordination with Police and Health Departments; and

Whereas, COVID-19 has pattern of transmission at rapid rate, in case prescribed prevention protocols including mass gathering and unnecessary movement etc are not strictly followed; and

Whereas, following issue of advisories by the Health authorities to prevent the spread of COVID-19 pandemic and break the transmission chain of the virus, it is necessary to enforce certain restrictions; and

Now, therefore in view of the above-mentioned facts and in the interest of safety and well-being of general public at large, **I, Mussarat Islam, KAS, District Magistrate and Chairperson, District Disaster Management Authority, Ramban**, in exercise of the powers vested in me under Section 144 Cr.P.C, Section 34 of National Disaster Management Act, 2005 and in accordance with Section 2 of the Epidemic Diseases Act, 1897 as well as in continuation to this office Order No DCR/COPVID-19/3152-70, dated 20.04.2021, do hereby impose complete ban on movement of individuals for all non-essential activities from **08.00 pm to 06.00 am every day** in the territorial jurisdiction of District Ramban with immediate effect, till further orders. Movement of the usual traffic along NH 44 shall remain exempted from the above restrictions


The Superintendent of Police, Ramban, shall ensure enforcement of the above order in letter & spirit

Any violation of this order shall invite action under Indian Penal Code/ Disaster Management Act, 2005 and Epidemic Diseases Act, 1897.
