General Terms & Condition

- The following documents are to be submitted with the Technical Bid:-
 - Self attested copy of GST Registration Certificate under GST Act, 2017.
 - Self attested copy of PAN
 - Self attested copy of Trade Licence certificate. Trade licence shall be upto date and valid on the day of opening of technical bid as stated in this NIT. Validity period of Trade Licence shall clearly be mentioned on the licence and must be legibile.
 - Copy of IT Return with respect to Assessment Year 2018-19.
 - Earnest money amounting to **Rs. 10,000/- (Rupees Ten Thousand) only will have to be submitted in the form of Demand Draft drawn in favour of the District Magistrate, Jhargram** from any recognized bank.
 - Credential in the form of payment certificate only (copy of work order or bank statement etc will not be enteryained) certificate for similar type of supply works amounting to at least Rs. 2,00,000/- (Rupees Two Lakh) only executed during last 5 (five) years i.e. not before 30th October, 2014.
- The **Financial Bid** of only successful Technical Bidders will be opened. The rates should be quoted both in figures and words in **Financial Bid** under letterhead of the tenderer as per attached format.
- Rates inclusive of all taxes should be quoted for individual items as per the specification given. No separate delivery charge/ incidental charge will be paid.
- Supply Order will be issued to the Item wise lowest bidder.**
- Required sizes of different items will be provided along with supply order.
- Materials to be supplied within 15 (fifteen) days from the date of issuing supply order.
- All taxes will be deducted as per existing norms.
- Supply order will be issued as and when required.
- The authority will form expert committee who will verify the materials with respect to the specifications mentioned in this NIT. After selection and on being intimated by the authority, the agency shall have to produce the samples before the expert committee within a period of maximum 7 (seven) days of receipt of intimation in this regard. Supply order/Work order will be issued only after clearance of the expert committee. Expert Committee will also check materials at the time of actual supply.
- During scrutiny, if it comes to the notice of the authority that any documents or credentials submitted by the tenderers found incorrect/ fabricated, the said agency will be debarred to participate in the process.
- The tender inviting authority reserves the right to cancel the NIT in case unavoidable circumstances & for that no claim will be entertained.
- This office is not bound to accept the lowest rate and this office can seek explanation or cost benefitanalysis from the agencies if the rate quoted by them is found to be higher than prevalent market rate.
- The undersigned reserves the right to distribute the work among different agencies without assigning any reason.
- The undersigned reserves the right to reject any or all the rates tendered without assigning any reasons.
- Selected tenderer must comply exactly with same rate quoted for all articles for supply of any volume upto 1(one) year from the date of acceptance of the rate(s).

- In case of unsuccessful tenderers, the earnest money will be refunded after finalization of tender & in case of successful tenderers the earnest money will be refunded after 60 days from the date of final payment.
