**Sub: Suspension of Riverbed Sand Mining Operation in the Monsoon Season.**

In pursuant to the Sand Mining Management Guidelines, 2016, issued by the Ministry of Environment, Forest and Climate change, Govt. of India and in accordance with the order of Jt. Secretary, Govt. of WB, Deptt. of Industry, Commerce & Industry vide order no 554-CI/O/MIN/GEN/MIS/32/2016 dated 23<sup>rd</sup> August, 2018 and subsequent clarification order no 578-CI/O/MIN/GEN/MIS/32/2016 dated 4<sup>th</sup> September, 2018, it is hereby ordered that riverbed sand mining operation shall remain suspended in the monsoon season in this district with effect from 15/07/2020.

The date of recommencement of riverbed sand mining will be informed later on.


