
**ORDER**

In terms of orders of the Chief Secretary to the Government of West Bengal issued vide Memo No. 177/CS/2020 dated 18/05/2020 and Memo No. 218-CS/2020 date 30/05/2020 which prescribed for lockdown measures in affected areas to effectively contain the spread of COVID-19, and in terms of SOP regarding affected areas (Containment Zones) issued by the Health & Family Welfare Department vide Memo No. H&FW/176/20 dated 01/06/2020 and after due consultation with the Superintendent of Police, Jhargram and the Chief Medical Officer of Health, Jhargram, the areas as mentioned in Annexure of this order are hereby categorized as Containment Zone (Affected area-Category A) It is further ordered that

1. The Sub-Divisional Officer Jhargram Sadar shall be responsible for all enforcement measures within the respective jurisdiction.
2. The Sub-Divisional Officer, Jhargram Sadar being Executive Magistrate, is hereby appointed to act as Incidence Commander for his respective jurisdiction.
3. Sub-Divisional level Task Force will arrange for surveillance of the containment areas by forming multidisciplinary team involving concerned officials of Jhargram Municipality, Community Health Worker, Civic Police, Anganwadi Workers, SHG members and other public representatives as deemed fit.
4. The Task Force shall ensure intensive lockdown surveillance, contact tracing and testing in containment zones and will also ensure home delivery of essential commodities in the affected areas.


The directives and clarification of contained in the orders of the Chief Secretary to the Government of West Bengal vide Memo No. 177-CS/220 dated 18/05/2020 and Memo No. 218-CS/2020 dated 30/05/2020 will apply *mutatis mutandis* and shall be complied by all concerned strictly.

This order will take effect on and from 14-08-2020 to 22-08-2020 and will remain in force for a period of 07 days or until further order. Further strict surveillance will continue for another 14 days.
