ORDER


In continuation of previous order in this matter, it is seen after analyzing cases that Covid infection rate in Jhargram Municipality has not reduced significantly. Hence to protect the people of Jhargram Municipal area from Covid infection and death and after discussion with Police, Health and Municipal authorities, timing for shops in Jhargram Municipal area from **05:00 am on Saturday, 10.07.2021 to 05:00 am on Thursday, 15.07.2021** will be as follows:-

- (i) Markets, haats, stalls for vegetables, fruits, flowers, fish, meat, milk-Daily 06:00 am to 11:00 am.
- (ii) All other shops-Daily 12:00 noon to 08:00 pm.
- ✓ Exceptions -Hospitals, Medicine shops, Nursing Homes, Diagnostic Centres, ATMs, Petrol Pump and LPG stores, Cable TV, Media, Home Delivery will function as per their normal timings, banks will remain open from 10:00 am to 02:00 pm.
 - ✓ Shops shall not sell to customers without masks. Any shop violating this may have their Trade license cancelled.
 - ✓ Shops shall ensure drawing chalk circles to ensure social distancing and rope barriers between counter and customers.

The restriction will be enforced by the Administrative and Police Authorities.

Persons violating restrictions, will be liable for imprisonment and fine under Natural Disaster Management Act. 2005 and Sec. 188, IPC. by the competent Court.

RTPCR/RAT tasting of all shopkeepers and drivers in Municipality area shall be carried out as transporters and markets were present.
