**ORDER**

In continuation of previous orders on this subject and after analyzing the Covid cases prevailing infection rates for the past 15 days, the Jhargram District Disaster Management Authority deems it necessary to restrict the interaction of people in order to protect them from Covid.

**[A] Hence the following Containment Zones are notified in Jhargram Municipality :-**



• Movement of persons into and out of containment zones, is not allowed, except for Health emergencies or provision of essential services.

**[B] From 01.08.21 to 15.08.21 :-**

- All Shops and stalls will operate at usual working hours but will close by 7 pm without fail.  
**Exception :** Hospitals, Medicine shops, Nursing Homes, Diagnostic Centres, ATMs, Petrol Pump and LPG stores, Cable TV, Media, Home Delivery will function as per their normal timings, banks will remain open from 10 am to 2 pm.
- Shops shall not sell to customers without masks. Social distance will be maintained between customers. Any shop violating this may have their Trade license cancelled.
- Shops shall ensure drawing chalk circles to ensure social distancing and rope barriers between counter and customers.
- Persons travelling in public transport without masks, shall be taken off the vehicle. The restriction will be enforced by the Administrative and Police Authorities.
- People moving in public places must ensure they have their noses and mouths securely covered. Social distance must be maintain in public places.
- All outdoor activities including movement of people and vehicles shall be strictly prohibited between **9 pm to 5 am** except for health services, law and order, movement of essential commodities including agricultural produce and other emergency services.

**[C]** Persons violating these restrictions will be liable for imprisonment and fine under National Disaster Management Act, 2005 and Sec. 188 IPC. by the competent Court, and other penalties.


