### **ORDER UNDER CLAUSE 11 FOR ACTIVE SURVEILLANCE**

WHEREAS, the World Health Organization has declared the COVID-19 outbreak as a pandemic and Government of India has directed State Government to take necessary steps to prevent and control the spread of this disease under the Epidemic Disease Act, 1897.

AND WHEREAS, the Government of Gujarat in exercise of the power conferred under Section 2, 3 & 4 of Epidemic Disease Act, 1897 has framed Regulations for prevention and containment of COVID-19 under Order No. GP/9/NCV/102020/SF-1/G, dated 13 March 2020 and addendum Issued vide Order No. NCV/102020/SF/-1/G, dated 20 March 2020.

AND WHEREAS, as per sub clause 5 of clause 11 of notification read as (i) "Initiating active and passive surveillance of COVID-19 cases."

**I, Aayush Oak, Collector & District Magistrate, Amreli** In exercise of the said powers conferred upon me as per sub clause 5 of clause 11 of notification read as (i) Initiating active and passive surveillance of COVID-19 cases. In order to identify the person having COVID-19 like symptoms I hereby direct to implement the following direction:

***"All the registered medical /drug stores or private hospitals or clinics which directly dispense drugs to patients shall record the following details as prescribed in Annexure-A of any person to whom any drug containing Paracetamol or Azithromycin is being sold with/without prescription."***

The above said information shall be complied by Drug inspector, Food and Drugs administration, Amreli and submitted to Dr. A.K. Singh(Mo-9727723302), District Surveillance Officer, Amreli within 24 hours of dispensing the drug to patients via Email ID-**dso.health.amreli@gmail.com**.

Taluka Health Officer of concerned jurisdiction, Chief District Health Officer, Amreli, District Surveillance Officer, Amreli, Drug inspector, Food and Drugs administration, Amreli are hereby authorized to take all necessary actions for implementation of the above measures.

Any person not complying with the directions mentioned above shall be liable for prosecution under section 188 and 269 of IPC.
