ORDER

G.S. KARALA Vs SURESH KUMAR GUPTA

By this Order, I shall dispose of the case under section 81 of Delhi Land Reform Act, 1954, which was instituted on the basis of Halka Patwari report submitted on 22.02.1994 which mentioned that the land bearing Khasra No.80/2 min (0-9), 2 min (0-4), 2 min (1-0), 2 min (0-14), 2 min (1-5) & 2 min (1-0) situated in the revenue estate of Village Karala, Tehsil Kanjhawala, New Delhi has been converted for non-agricultural use by the respondent by way of unauthorized construction thereby contravening the provision of Section 81 of DLR Act.

Thereafter, a conditional order under section 81, DLR Act was issued on 22.02.2001 directing the respondents to convert the land back into the agriculture purposes within three months from the date of the order, failing which the said land shall be vested into Gaon Sabha and the respondents shall be ejected from the above mentioned land. However, no compliance to the above said order was done.

As per the latest Halka Patwari report dated 23.10.2020, boundary wall and houses are constructed on khasra no.80//2 situated in the revenue estate of village Karala, Delhi. Further the revenue record khasra no.80//2 min (0-9), (0-4), (1-0), (0-14), (1-15), (1-0) has been acquire^d vide award no.22/2005-06.

Therefore, I SAUMYA SHARMA, RA/SDM (KANJHAWALA), in exercise of powers conferred upon me as RA (Kanjhawala) under the Delhi land Reform Act, 1954 order that on account of land being acquired, proceeding under section 81 of DLR Act are being hereby dropped in respect of Khasra No. 80/2 min (0-9), 2 min (0-4), 2 min (1-0), 2 min (0-14), 2 min (1-5) & 2 min (1-0) situated in the revenue estate of Village Karala, Tehsil Kanjhawala, New Delhi.

Copy of this order to be sent to Tehsildar (Kanjhawala), concerned Kanungo and Patwari for updating the land records.
