ORDER

By this order, I shall dispose of the case under section 145 of Cr. PC, which was instituted on the basis of Kalandra under section 145 Cr. PC received from PS Kanjhawala vide DD No.39-A dated 20.10.2014.

Vide police Kalandra dated 20.10.2014 it has been informed that there was dispute between Sh. Mahinder Gupta and Sh. Gurpreet Singh regarding possession and ownership of plot no.D-51, Durga Enclave, Delhi and due to which both the parties were engaged in a scuffle.

On the basis of police Kalandra, both the parties were issued notice to appear and submit their statements in the court of undersigned.

On the perusal of case file, concerned parties were heard and given opportunity on various dates in this court to submit their comments/ submissions.

As per the report from PS Kanjhawala available in the case file, it is reported that during the local enquiry it is found that the Plot no. D-51 (out of khasra no.1052) measuring 100 sq was purchased by Sh. Gurpreet Singh S/o Joginder from Sh. Raghupal in the year 2012 and that local residents also identify the plot in question as belonging to one Sh. Gurpreet Singh S/o Sh. Joginder Singh. The report further submitted that the plot is in the possession of Sh. Joginder Singh.

Further, the Halka Patwari report submitted alongwith photographs, and duly verified by field kanungo and validated by Tehsildar (Kanjhawala) dated 23.01.2021, has stated that as per local enquiry conducted, it was found that the property situated at plot no. D-51, Durga Enclave, Punjab Khore, Delhi, belongs to Sh. Joginder Singh.

Upon hearing the respondent & perusing the records, found on the file, it is clear that Sh. Joginder Singh S/o Lt. Sh. Bhag Singh is in the possession of the property situated at plot no.D-51, Durga Enclave, Punjab Khore, Delhi.
