ORDER

G.S. QUTABGARH V/S RAI SINGH & ORS

1. By this order, I shall dispose off the application filed under Rule 6 Appendix 14 of Delhi Land Reforms Act, 1954 filed by the respondents in reference to order for vesting of land under section 81 of DLR Act in respect of Khasra No.20//4/2 (2-4), 7/2 (3-18) & 14/2 (1-16) village Qutabgarh, Delhi vide case no.1198/RA/87 dated 18.12.1987, which was passed ex-parte.
2. Halka Patwari vide his report dated 22.02.2021 submitted that the land bearing khasra no.20//4/2 (2-4), 7/2 (3-18) & 14/2 (1-16) situated in the revenue estate of village Qutabgarh, Delhi is being used for agricultural purposes and at present wheat crop is standing on the site.
3. Further, respondent appeared before this court and has submitted that agricultural use of land is taking place. Respondent's written submission is on record and showcasing

agricultural use of land at present on the site are also on record. Admittedly the farm is low lying, however cultivation is taking place.

4. In view of above it is clear that agriculture use of the land is taking place and ingredients of Rule 6 Appendix 14 application are also made out. Now therefore, I SAUMYA SHARMA, IAS, RA/SDM (KANJHAWALA) in exercise of power conferred upon me as RA (Kanjhawala), hold that the present application under section 6/14 of the Delhi Land Reforms Act, 1954 stands allowed land bearing Khasra No.20//4/2 (2-4), 7/2 (3-18) & 14/2 (1-16) shall revert back to the applicants.

Tehsildar (Kanjhawala), concerned Kanungo and Patwari are directed to update the land record accordingly.
