ORDER

G. S. KARALA V/S GANGA BISHAN

1. By this Order, I shall dispose of the case under section 81 of Delhi Land Reform Act, 1954, which was instituted on the basis of Halka Patwari report submitted alongwith photographs, and duly verified by field kanungo and validated by Tehsildar (Kanjhawala) on 22.02.1994 which mentioned that the land bearing Khasra no.71//16 (1-10) situated in the revenue estate of Village Karala, Tehsil Kanjhawala, New Delhi has been converted for non-agricultural use by the respondent by way of construction of boundary wall thereby contravening the provision of section 81 of DLR Act.
2. After perusing the report filed by the Halka Patwari, stay order was issued on 25.03.1999 with the direction to respondent to restrain from using the land for non-agricultural purpose including any kind of construction thereon. SHO, Kanjhawala was further directed to stop the unauthorized construction on agricultural land and submit report.





3. No compliance report of conditional order dated 12.02.2001, has been received/ available in the case file. Further, many opportunities were given to the respondent to appear for hearing in the court of undersigned, but he failed to appear in the court to submit reply despite notices.
4. As per the latest Halka Patwari report dated 20.02.2021, it is mentioned that sahid bhagat singh colony is found constructed on the land bearing Khasra no.28/1 (4-16) situated in the revenue estate of Village Mohd. Pur Majri, Delhi and the land is entirely built-up. No trace of agricultural activity is found on the said land.
5. In view of above, I SAUMYA SHARMA, IAS, RA/SDM (KANJHAWALA) in exercise of power conferred upon me as RA (Kanjhawala) under section 81 of the Delhi Land Reforms Act, 1954 hereby order that the proceedings under section 81 of DLR Act in r/o land bearing kh.no.28/1 (4-16) situated in the revenue estate of Village Mohd. Pur Majri, Delhi shall be vested into gram sabha.

Tehsildar (Kanjhawala), concerned Kanungo and Patwari are directed to update the land record accordingly.


