ORDER

WHEREAS, the Government land situated Ward-F, Block-1, T.S.No.43/2 of Karaikal Revenue Village was transferred to the Central Hindi Directorate for construction of Dakshina Bharat Hindi Prachar Sabha, vide G.O.Ms.No.01/2016 dated 19.01.2016.

2. AND WHEREAS, the Central Hindi Directorate has not taken possession of the land due to their administrative reasons.

3. AND WHEREAS, the land deemed to be vested to the Department of Revenue and Disaster Management as per para 5 of G.O.Ms.No.01/2016 which reads as if the land is not utilized for intended purpose within three years the land shall stand reverted to the Department of Revenue and Disaster Management.

3. AND WHEREAS, it has been requested to condone the delay caused on taking over possession of the land and if the lands were transferred and handed over, they will put into use as necessary funds for construction of building in Karaikal were allocated in their Budget Provisions 2019-20.

4. AND WHEREAS, the District Collector, Karaikal has recommended for condoning the delay and re-allotment of land to Central Hindi Directorate
