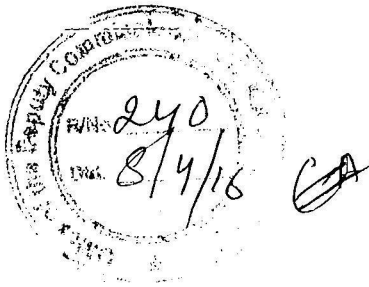


**NOTIFICATION**

In pursuance of the Cabinet decision dated 16<sup>th</sup> March'2016 under Agenda item No. 04, the Governor of Arunachal Pradesh is pleased to notify the following specifications for Right of Way (ROW) Viz. Widening of existing 2-Lane to 4-Lane Dual Carriage Way of NH-52A (New NH-415) from Itanagar to Banderdewa:

1. **Right of Way (RoW) of 30 (thirty) metres in the built up area for the proposed 4-Lane Highway from Itanagar to Banderdewa is as below:**
  - I. Itanagar (Chandranagar bridge to Hotel Todo)
  - II. Naharlagun (Him petrol pump to Kankarnallah bridge)
  - III. Nirjuli (Bage Tinali to Veterinary Directorate)
2. Right of Way (ROW) of 40 metres in the Greenfield /open area other than the stretch mentioned above for the proposed 4-lane Highway from Itanagar to Banderdewa.
3. No compensation shall be paid for the land or structures falling within the Right of Way of existing alignment of NH-415.
4. Compensation for land or structures will be provided to the only locations where the alignment is changed due to the design consideration.

Therefore, the Highway Division of PWD in consultation with Secretary (Land Management) and Deputy Commissioner, Capital Complex is directed to carry out the detail survey to assess the quantum of compensation on the basis of aforementioned specifications of Right of Way (ROW) for NH- 415 from Itanagar to Banderdewa.
