

TERMS AND CONDITIONS

- 01 The Educational qualification Certificates, Driving Licence, Character Certificate, Himachali Certificate, Schedule Caste/Schedule Tribe/Backward Classes certificate, etc. (if applicable) issued by the competent authority will have to be produced at the time of joining.
- 02 That the appointment shall be subject to medical fitness for which a certificate of fitness from the Chief Medical Officer/Medical Officer concerned shall have to be produced by them.
- 03 That the services will be purely on temporary basis and the same is liable to be terminated in case his/her performance/conduct is not found satisfactory.
04. The appointment shall be subject to the verification of character and antecedents of the candidate.
05. That on appointment they shall carry the liability to serve in any part of Shimla District.
06. That an oath of allegiance to the constitution of India shall have to be taken.
07. No traveling allowance shall be paid for joining the post.
08. That the candidates shall not be entitled for any kind of leave.

If the offer of appointment on the above terms and conditions is acceptable to them, they shall submit their joining report at their place of posting with in 15 days from the date of issue of this order failing which the offer shall stand cancelled.


