**NOTIFICATION**

Whereas, the Sub Divisional Magistrate Kumarsain has proposed the Traffic Plan for Kumarsain, Narkanda and Kingal regarding parking plan, no parking zone and loading & unloading points to facilitate the general public and to regulate the flow of traffic. She has requested to notify the Traffic Plan under the provisions of Motor Vehicles Act 1988.

**1. Narkanda.**


