**ORDER**

**Whereas**, prohibitory order under Section 144 of Code of Criminal Procedure, 1973 was passed by the undersigned vide this office No. SML-PSH-(7)/2004-Part-II-654-68 dated 24-03-2020 in the entire Shimla district for the containment and prevention of the spread of COVID-19.

**Whereas**, as per Section 144 (4) Cr. PC, the stipulated period of prohibitory order was going to expire on 23-05-2020 but keeping in view the present position regarding the COVID-19 positive cases, the Additional Chief Secretary (Home) to the Government of Himachal Pradesh was requested vide this office letter No. SML-ADM (L&O)/COVID-19-1748 dated 22-05-2020 for extension of the time period of Order issued by undersigned U/S 144 of Cr.PC on 24-03-2020 and all subsequent orders issued in continuation of the same for further period.

**Whereas**, the Additional Chief Secretary (Home) to the Government of Himachal Pradesh vide notification No. Home (A)A(9)-12/2020 dated 23-05-2020 has conveyed the authorisation by the Governor of Himachal Pradesh to the undersigned to extend the period of aforesaid Order dated 23-03-2020 upto 30-06-2020, from the date of expiry of the same.

**Now therefore**, I, Amit Kashyap, IAS, District Magistrate, Shimla in pursuance of notification No. Home (A)A(9)-12/2020 dated 23-05-2020 of Additional Chief Secretary (Home) to the Government of Himachal Pradesh and in exercise of the powers vested in me under Section 144 of the Cr. PC, do hereby extend the period of Prohibitory Order passed on 24-03-2020 and all subsequent orders upto 30-06-2020.

Violation of this order shall attract provisions of Sections 188, 269, 270 and 271 of IPC and all other relevant provisions of law and the violators shall be prosecuted accordingly.

This order shall come into force w.e.f 24-05-2020 in the entire territorial jurisdiction of district Shimla.


