Order U/S 34 of the Disaster Management Act, 2005

In pursuance to the order No. Rev (DMC) (C) 20-2/2020-COVID-19 dated 24-09-2021 issued by the Chief Secretary-cum-Chairperson, SEC, Himachal Pradesh and in continuation to this office order No. SML-ADM (L&O)/COVID-19-2502-14 dated 23-09-2021, I, Aditya Negi, IAS, Chairman, District Disaster Management Authority-cum-District Magistrate, Shimla, exercising the powers conferred in me under Section 34 of the Disaster Management Act, 2005, do hereby order that:-

Education Department is allowed to open the Schools from Class 9th onwards w.e.f. 27-09-2021. Education Department shall bring out a Standard Operating Procedure (SOP) to ensure that the classes are staggered in such a manner so as to avoid congestion and also take required steps as necessary in order to adhere safety guidelines and appropriate behaviour as per COVID-19 protocols.

It shall be the responsibility of the Superintendent of Police, Shimla, concerned Sub-Divisional Magistrates and the representatives of concerned PRIs/ ULBs to implement these orders within their jurisdiction.

This order shall come into force with immediate effect in the entire territorial jurisdiction of Shimla District and will remain in force till further orders and all other restrictions and relaxations shall remain same as per previous orders.

Violation of the order shall attract provisions of Section 51 to 60 of Disaster Management Act, 2005 and Section 188, 269 & 270 of IPC. The violators shall be prosecuted accordingly.
