

**OFFICE OF THE DISTRICT MAGISTRATE, PALWAL**

**Order**

WHEREAS, in exercise of power conferred under Section 144 of Cr.P.C. an order has been issued vide Memo No.6621-6642/ M.B dated 23.03.2020

WHEREAS, for proper implementation of the order, in continuation of that order the following directions are passed:-

1. All vehicles/persons in bona-fide transit (inter-state/inter district) shall be allowed to pass but only after due verification of point of origin and destination.
2. Government employees tasked with emergency and essential services of law and order, health, Municipal services, Electricity, Fire, Media and Government machinery tasks with the responsibility in relation to COVID-19 shall be allowed to attend duty on production of their official ID Cards.
3. Government employees of non-emergency departments but on official essential duty in their offices shall be allowed upon production of valid duty order from head of office/department on official ID Card. It is clarified that ID card alone will not suffice unless there is a duty order of concerned HOD. HOD would be required to adhere to the GOI DoPT-OM No.F.No.11013/9/2014-Estt-(A-III) Dated 22.03.2020, wherein all HoDs are required to work with only skeleton staff for essential services.
4. Health services personnel such as Doctors, Nurses, Pharmacist and all other staff shall be allowed to attend duties on production of ID cards from their respective institutions – Government Civil Hospital, Palwal, CHC etc. as well as Private Hospitals.
5. Hospital and Chemist shops shall remain open. Chemist shop owners need to get passes of their personnel made by 05:30 PM on 25.03.2020,
6. Media persons with accreditation and recognition by the Government (Haryana/Gol. )
7. For maintenance of the following essential services, the below mentioned officers shall be responsible to coordinate and facilitate the issuance of passes.
  - (a) Nodal Officers & Duty Magistrates in their respective Jurisdiction can issue passes for vehicles& persons.
  - (b) Sh. Bijender Kumar DIPRO, Palwal (8930335558) is responsible for facilitation of passes for electronic and print media as well as media establishment.
  - (c) Sh. Ram Avtar singh, DFSC, Palwal (9467059434) for all passes relating to facilitating continuous supply of food stuff etc. including the maintenance of supply chain.
  - (d) Sh. Hardeep Singh, E.O, M.C Palwal, Hodal (9728190902) and Sh. Devinder, Secy. M.C, Hathin (8950679055) for facilitating. Passes to all MC Staff including vendors tasked with supplying food stuff in different neighbourhoods.
  - (e) The Concerned SDMs, Palwal/Hodal/Hathin in their respective sub-divisions would facilitate Lockdown passes for essential services provided by private organizations and for facilitation of passes for the Hon'ble Punjab and Haryana High Court, Chandigarh & District Court, Palwal, and District Administration Palwal.
  - (f) The passes should be prepared in duplicate with due no. & date and one copy may be retained for record and verification.
