

ORDER UNDER SECTION 144 OF THE CODE OF CRIMINAL PROCEDURE, 1973

(In continuation of this office endst. order no. 6055-6085/M.B., Dated 17.03.2020)

WHEAEAS information has been laid before me that Novel Corona virus (COVID-19) continues to spread around the country, which is dangerous to human life. Moreover, as of now, no vaccine has been developed for the said virus. In the light of this fact, prevention appears to be the best cure available so far. It is also known fact that mass gathering of people at all Social, Cultural, Sports, Political, Religious, and Family events may cause of spreading the ibid virus from person to person, which is dangerous to human being and may lead to serious law and order problem in the district. The Government of Haryana has also framed the Haryana Epidemic Disease, COVID-19 Regulations 2020 to avoid the spreading of Corona virus (COVID-19). It is also necessary to ensure that no inconvenience is caused to the public in the district of Palwal.

And whereas it has been made appear to me that there is a need of restriction on mass gatherings of people at all Social, Cultural, Sports, Political, Religious and Family events to prevent the transmission of the said virus being dangerous to human life. I am satisfied from the material placed before me that there are sufficient grounds for proceedings **under section 144 of the Code of Criminal Procedure, 1973**, and that immediate prevention is desirable and the situation if not properly checked immediately may lead to undesirable consequences paralyzing the peaceful atmosphere.

Now, therefore, **I, Naresh Narwal, IAS, District Magistrate, Palwal** in exercise of the powers vested in me by virtue of Section 11 of the Code of Criminal Procedure, 1973 do hereby prohibit gatherings of twenty or more than twenty people in public places and at all Social, Cultural, Sports, Political, Religious and Family events to prevent the transmission of the ibid virus.

Now, it is also necessary to impose the following restrictions in the district:-

- a) All Play schools and Coaching Centres shall remain closed till 31.03.2020.
- b) All roads side dhabas along National Highways, State Highways and other roads must be closed till 31.03.2020.
- c) All restaurants shall maintain One meter distance between tables and open air sittings be encouraged wherever practical with adequate distancing.
- d) All Quarantine persons must be stayed at their home till the clearance of medical team. If they found break the quarantine, they should be picked up and shall be kept in Government Quarantine Centers with the help of Medical Team, if necessary. A notice should be pasted at home of Quarantined person and inform the local RWAs that if they breaks quarantine they shall inform the district administration.
- e) Compliance of the orders/instructions received from the Government and District Administration time to time.


Superintendent of Police, Palwal and Sub Divisional Magistrates in their respective areas shall be responsible for enforcement of above prohibitory order in letter and spirit.

This order shall be applicable in the entire area of the District Palwal and shall come in force from the date of issuance till 31.03.2020.

This order shall be promulgated throughout the limits of Palwal district by beat of Drums by announcement through Publicity Van of Public Relations Department and by affixing copies of this order on the Notice Boards of District, Sub Divisional and Tehsil Offices and other Public Places.

In view of the requirement of the situation which has become emergent, this order is passed ex-parte and is addressed to the public in general.
