
S. N.	Restricted activities/ services
1.	Operation of Educational Institutes (Govt./Private), Cinemas, Gyms, Night Clubs, Pubs, Coaching Centers and Play Schools.
2.	Assembly of Twenty and more than twenty people in Public Places and at all Social/ Cultural/ Political/ Religious/Academic/ Sports/Seminars/Conferences.
3.	Checking of stock of Masks/ Hand Sanitizers/ Hand wash/ Liquid Soaps etc. and selling of such items on higher prices than MRP.
4.	To accompany the Medical Team during visit of the home of any Quarantine persons, if necessary.
5.	To ensure compliance of Janta Curfew on March 22 nd (Sunday) from 07.00 A.M to 09.00 P.M. Siren is blown on 22.03.2020 (Sunday) at 05.00 PM at District, Sub Division, Tehsil, Sub-Tehsil and Block Headquarters so that people may come out and cheer the services of the people working in essential services.
6.	Compliance of the orders/instructions received from the Government and District Administration time to time.
7.	All Duty Magistrates shall attend a meeting on daily basis at 05.00 P.M at Conference Room, Distt. Sectt. Palwal about the whole day activities pertaining to COVID-19 and their action taken. Thereafter press briefing would be held at conference room of Distt. Sectt. Palwal and health bulletin would be issued.

The Duty Magistrates will exercise the powers of Executive Magistrate vested in them by the Code of Criminal Procedure 1973.


The Sub Divisional Magistrates, Palwal / Hodal / Hathin will be overall incharge in their respective Sub Divisions.
