ORDER

WHEREAS information has been laid before me that Novel Corona virus (COVID-19) continues to spread around the country, which is dangerous to human life. Moreover, as of now, no vaccine has been developed for the said virus. In the light of this fact, prevention appears to be the best cure available so far. The Government of Haryana has also framed the Haryana Epidemic Disease, COVID-19 Regulations 2020 to avoid the spreading of Corona virus (COVID-19). Whereas in exercise of the powers under section 6 (2) (i) of the Disaster Management Act, 2005, the National Disaster Management has issued an order No. 40-3/2020-DM-I (A) dated 29.03.2020 directing the State authorities to take effective measures so as to prevent the violations of lockdown measures and maintain the social distancing during COVID-19. The Chief Secretary, Government of Haryana has issued the directions vide letter No. 41/14/2016-5Pol dated 29.03.2020 for implementation of said order. Therefore, it is imperative to adopt strict social distancing and isolation measures to contain the spread of COVID-19. It is also necessary to ensure that no inconvenience is caused to the public in the district of Palwal.
