3. If any services of drone mapping / surveillance through Survey of India being deployed, the details thereof.
4. Status of the working control room.
5. Name & Mobile No. of Nodal Officer appointed for monitoring the whole process in control room as well as in the field.
6. The instances violation of containment compliances, if any, with complete details and copy of footage regarding the same is forwarded to this office and Superintending of Police for taking immediate necessary corrective action.

**Subject:-** Directions given during the Video Conference meeting of Crisis Coordination Committee held at 12:00 Noon on 13<sup>th</sup> April, 2020 in Main Committee Room, Haryana Civil Secretariat, Chandigarh under the Chairpersonship of Chief Secretary, Haryana.

It was directed during the Video Conference meeting of Crisis Coordination Committee held yesterday i.e., 13.04.2020 under the Chairpersonship of the Chief Secretary to Government of Haryana that the monitoring of intensive containment areas shall be carried out by installation of CCTV cameras & drone mapping/surveillance of such areas through Survey of India be also explored. The copy of the minutes is attached herewith for ready reference.

2. Hence, please arrange to install sufficient number of CCTV cameras at suitable points so that all the areas within containment declared by the Government shall be visible. A control room for checking & monitoring of these CCTV cameras be also established. The daily report in this regard should be submitted regarding following points:-

- (i) Total number of CCTV cameras installed.
- (ii) Number of CCTV cameras working (on daily basis).
- (iii) If any services of drone mapping/surveillance through Survey of India being deployed, the details thereof.
- (iv) Status of the working of Control Room.
- (v) Name & Mobile No. of Nodal Officer appointed for monitoring the whole process in the Control Room as well as in the field.
- (vi) The instances of violation of containment compliances, if any, with complete details and copy of footage regarding the same be forwarded to concerned Deputy Commissioner & Commissioner of Police/ Superintendent of Police for taking immediate necessary corrective action.
