ORDER

In accordance to Civil Surgeon, Palwal letter No. War/Room/CS/Pwl/2020-13 dated 05.05.2020, it has been informed that 13 corona positive cases have been reported from Viral Testing Laboratory, PGMIS, Rohtak in Hathin, therefore the entire geographical area falling under 9 villages of Hathin Sub-Division i.e. Kot, Ghudawali, Lakhnaka, Babupur Hathin, Jalalpur, Guruksar, Alimeo, Pahadpur and Uttawar were declared as containment zone and adjoining villages viz. Pavasar, Ranyala Khurd, Khilluka, Nagal Jat, Roopnagar Natoli, Hudithal, Gohpur, Kukarchati, Buraka Hathin, Bighawali, Dheeranki, Ghinghdaka, Meerka, Roopraaka, Chilli, Malpuri, Maluka, Tonka, Kumrehda, Malai, Ali Brahaman, Andhop, Khaika, Bhudpur, Jarali, Mankaki and Ladmaki declared as buffer zone vide letter No. 8097-8111/ MB dated 04.04.2020.

As from last 4 weeks there is no positive case of COVID-19, the scaling down the operations of Containment plan can be initiated from dated 05.05.2020. But as on 03.05.2020 a new Corona positive case has been reported from village Ghudawali, so this will continue as a containment zone for next four weeks.

Further vide order Endst. No. 8485-8499 /MB dated 06.04.2020 village Roopraaka, Block Hathin was declared as Containment Zone and adjoining villages viz. Pahari, Mohdamka, Andhrola and Pachanka were declared as Buffer Zone

As from last 4 weeks there is no positive case of COVID-19, the scaling down the operations of containment plan can be initiated from dated 05.05.2020.

Whereas vide DO letter No. 32020/5/2009-EMR Part-II dated 04.04.2020, Joint Secretary, Ministry of Health & Family Welfare, Govt. of India has directed that the operations will be scaled down if no secondary laboratory confirmed COVID-19 case is reported from the geographical quarantine zone for at least four weeks after the last confirmed test has been isolated and all his contacts have been followed up for 28 days. The containment operation shall be deemed to be over 28 days from the discharge of last confirmed case (following negative tests as per discharge policy) from the designated health facility i.e. when the follow up of hospital contact will be completed.

Now, therefore in the situation as stated above, villages viz. Kot, Ghudawali, Lakhnaka, Babupur Hathin, Jalalpur, Guruksar, Alimeo, Pahadpur, Uttawar & Roopraaka *except vill. Gudhawali* which were declared as containment zone and all villages of buffer zone *except vill. Tonka* respectively vide order No. letter No. 8097-8111/ MB dated 04.04.2020 and order No. 8485-8499 /MB dated 06.04.2020 are hereby de-notified as containment zone and buffer zone with immediate effect.
