

ORDER

Whereas the MHA Govt. of India, vide its order No. 40-3/2020-DM-1 (A) dated 29.06.2020 has extended the lockdown upto **31.07.2020**, I, **Naresh Narwal, IAS, District Magistrate, Palwal** invoking the powers conferred under section 144 Cr.P.C do hereby prohibit the following in the interest of maintenance of public health, hygiene and safety in view of the COVID-19 pandemic.

Movement of any individual whatsoever for non-essential purposes shall henceforth remain restricted between 10.00 PM to 05.00 AM within the district, as well as movement outward the district, except for essential activities, including operation of industrial units in multiple shifts, movement of persons and goods on National and State Highways, loading and unloading of cargo and travel of persons to their destinations after disembarking from buses, trains and airplanes. Persons above the age of 65, persons with co-morbidities, pregnant women, and children below the age of 10 years shall not come out in open except in the case of a medical emergency or essential requirement as specified in the national directives. It may also be ensured that no organization/manager of public place shall allow gathering of 5 or more persons.


The compliance of this order shall be strictly enforced and ensured by all Executive Magistrates/ Police Officials on duty and any violation of the same shall be strictly dealt with as per sections of 188, 269 and 270 of the Indian Penal Code, 1860.

The order shall be promulgated by uploading it on the District website, circulated it through Whatsapp groups, and on other mediums of social/ digital media. Whenever the same is not possible through these methods, means of mass communication like radio, television may also be used and publicity vans be also deployed to disseminate the same.

This order shall be applicable in the entire area of the District Palwal and shall come in force from **01.07.2020 to 31.07.2020**.

In view of the requirement of the situation which has become emergent, this order is passed ex-parte and is addressed to the public in general.
