PRELIMINARY NOTIFICATION

Whereas it appears to the Government of India that a total of **2.60.0 hectares** of Dry land is required in the **Inathukkanpatti** village of **Thanjavur** Taluk in **Thanjavur** District for public purpose, namely for extension of Air Force Station, Thanjavur.

(The Hon'ble Madurai Bench of Madras High Court in its order dated.03.10.2018 in Cont P (MD) 86 & 87 of 2018 have ordered to pay compensation to the land owners within 04.01.2019. Since the land is urgently required for extension of Air force station, which is strategic importance for Indian Air force, and further the land owners have already vacated the land and the same is now within the premises of requiring body, under sub-section (1) of section 40 of the said Act, it has been decided not to carry out the Social Impact Assessment Study.)

Therefore, it is notified that for the above said project in the Inathukkanpatti village of Thanjavur Taluk in Thanjavur District, land measuring an extent of **2,60.0 hectares**, specified in the Schedule below, is under acquisition.

This notification is made under Sub-section (1) of section 11 of the Right to Fair Compensation and Transparency in Land acquisition, Rehabilitation and Resettlement Act, 2013 (Central Act 30 of 2013), to all whom it may concern.


A Plan of the land may be inspected in the office of the Collector and staffs deputed specially for this purpose on any working day during the working hours.

The Government is pleased to authorize the District Collector, Thanjavur and his staff to enter upon a survey land, take levels of any land, dig or bore into the sub-soil and do all other acts required for the proper execution of their work as provided and specified in section 12 of the said Act.

Under sub-section (4) of section 11 of the said Act, no person shall make any transaction or cause any transaction of land i.e., sale / purchase etc., or create any encumbrances on such land from the date of publication of this notification in the Tamil Nadu Government Gazette without prior approval of the Collector.

Objections to the acquisition, if any, may be filed by the person interested within 7 (seven) days from the date of publication of this notification in the Tamil Nadu Government Gazette as provided under sub section 4 of section 40 of the said act before the collector.
