**CURFEW ORDER UNDER SECTION 144 CrPC**

No. EJHD/Con.11/2013/196,

Dated Khliehriat, the 17<sup>th</sup> May, 2020

Whereas, in view of the prevailing situation concerning COVID 19 in the country and globally

Whereas to put in place preventive and mitigation measures to identify and take more stringent steps so the pandemic of COVID-19 is contained, reduced and eliminated in East Jaintia hills District and Meghalaya by way of ensuring observance of strict protocols of the Advisories issued by Government of Meghalaya in the Health & Family Welfare Department.

Now Therefore, I Shri F. M Doph. IAS District Magistrate. East Jaintia Hills District Khliehriat in exercise of the powers conferred upon me under section 144 Cr PC read together with Regulation 3 of the Meghalaya Epidemic Diseases. COVID-19 Regulations,2020 and Guideline No 5(1) of Order Dated 1<sup>st</sup> May 2020 of Government of India in the Ministry of Home Affairs do hereby promulgate **NIGHT CURFEW** in East Jaintia Hills District with effect from **18<sup>th</sup> of may,2020(Monday) upto 31<sup>st</sup> of may 2020 (Sunday) only for timings falling between 7.PM to 6.AM each day.**

This Order will **Not** apply to

1. Security Forces
2. Medical Teams on duty
3. Wholesale and Retail a Pharmacies
4. Police and Armed Force
5. Fire Emergency Service
6. MeECL. NEEPCO & power Grid
7. Food and Civil Supply Department
8. FCI
9. Public Works department (PWD)
10. Public Health Engineering (PHE) Department
11. Postal Service Telecom, Communication & IT Services
12. Press ,Print & Electronic Media
13. Petrol Pumps
14. Essential services including Health Services and online/home food delivery
15. Authorized workshops and designated spare parts dealerships of Health and Family Welfare Department. Govt of Meghalaya.
16. Government Officials on Duty.

These Services shall strictly comply with all protocols and procedures including social distancing, limiting of field staff to the barest minimum and other advisories of Government in the Health and Family Welfare Department, without fail.

Also, movement of vehicles carrying essential goods security forces medical equipments and shops for repair of truck on highways exempted However, Drivers and attendants of the vehicles shall be subject to medical screening as per laid down protocols

Curfew passes for timings falling between 7.00PM to 6.00AM with effect from 18<sup>th</sup> May 2020(Monday) upto 31<sup>st</sup> May 2020(Sunday) to be obtained by offline application to the office of the undersigned along with headmen certificate for such specific needs.
