



**ORDERS**  
**(11.05.2021)**

No. EJHD/Con.11/2013/Pt.IV/1 :Whereas, it is learnt that some unknown organizations have flouted all norms and order imposed by the Government relating to restriction of social gathering in the State in general and in the district in particular by clandestinely organizing bullfight events ( Iatur Masi ) in various locations in the District.

Whereas such events , programmes etc conducted by these organization are detrimental to public health in the present Covid situation and are in gross violation of the orders passed by the Government restricting all kinds of social gathering be it social, religious etc.

Whereas, I am of the opinion that such social gathering and bullfight events (**Iatur Masi**) should be prohibited in order to prevent the surge of covid -19 rise in the district.

Therefore, I Shri. E. Kharmalki, IAS District Magistrate, in exercise of the powers conferred upon section 144 Crpc read together with section 51 to 60 of the Dissaster Management Act, 2002 and Section 188 IPC East Jaintia Hills District do hereby prohibit the followings :

1. Any Assembly of persons or social gathering whatsoever.
2. Bullfight events (Iatur Masi) in the district.

In view of the urgency of the matter, this order has been made ex parte.
