No. EJHD/Con.11/2013/Pt.IV/8: In continuation to this office order No. EJHD/ Con.11/2013/Pt.IV/7 dated Khliehriat the 20.05.2021 and in order to safeguard from an uncontrollable surge in Covid-19 cases. Therefore all essential shops shall be open on the **31<sup>st</sup> May, 2021 (Monday)** in the Market areas of Khliehriat East & West, whole of Ladrymbai, Umpleng Chiehruphi , Lumshnong, Sohkvmpchor, Sookilo, Saipung, Semasi, Jalaphet, Rymbai, Wapung, Sutnga, Bataw and Umkiang from 9.00 A.M to 3.00 P.M and all locality shops to be strictly regulated by the Durbar Chnong/ Market Committee. 50 % of the Essential , hardware and Electrical shops shall be opened as regulated by the Durbar Chnong/Market Committee

*Any violation and non-compliance to SOPs will make the establishment liable for closure and any person (S) violated the lockdown restriction shall be booked under Section 51 (b) , 52, & 54 of the Disaster Management Act, 2005 Section 3 of the Epidemic Diseases Act, 1897, Section 188 IPC and Section 7 of the Essential Commodities Act, 1985.*


