



ORDER
(04.06.2021)

No. EJHD/Con.11/2013/PLIV/10: In continuation to this office order No. EJHD/ Con.11/2013/PLIV/9 dated Khlichriat the 29th May, 2021 and in order to safeguard from an uncontrollable surge in Covid-19 cases and to ensure essential commodities are available to the citizens in the notified markets. Therefore all essential shops shall be open on 7.06.2021, 09.06.2021 and 11.06.2021 June 2021 (Monday, Wednesday and Friday) in the major Market areas of Khlichriat East & West, whole of Ladrymbai, Umpleng Chiehruphi , Lumshnong, Sohkympchor, Sookilo, Saipung, Semasi, Jalaphet, Rymbai, Wapung, Sutnga, Bataw and Umkiang from 9.00 A.M to 3.00 P.M and all locality shops to be strictly regulated by the Durbar Chnong/ Market Committee.

50 % of the Essential , hardware and Electrical shops including mobile shops, spare parts , textiles shall be opened as regulated by the Durbar Chnong/Market Committee

1. Inter District movement of persons is not permitted. No person is to step out without valid reason . Vehicles without passes will be liable for strict penalties. Any one in defiance of orders is liable for arrest.
2. Standalone locality shops will be permitted to open from 2.00 P.M upto 6. 00 P.M only with strict protocols / advisories and to be regulated by the Durbar Chnong/ VDPs.
3. In situ construction works for Government and private projects that do not involve movement of labor are permitted with due permission from this office.
4. Political, public social and religious gatherings including conferences, meetings and trainings wedding and sporting **are not permitted.**
5. Only central Government officers as notified by Home (Political) department vide Notification No. POL.117/2021 dated 4th June, 2021 and State Government offices as notified by Personnel & A.R (A) department vide notification No. PER.62/2020/57, dated 28.05.2021 are permitted to open with limited strength.
6. **All Post offices are permitted to open on the 7.06.2021, 9.06.2021 and 11.06.2020 (Monday, Wednesday and Friday) with limited staff and they shall close by 3.00 P.M.**
7. **All banks are permitted to open from Monday to Friday with limited staff.**
8. **Authorized Home delivery services** only will be permitted
9. Funeral gatherings should be restricted to 20 persons.

Exemptions:

1. Health services including emergency services and vaccination. Person (s) moving for vaccination should be able to produce proof of COWIN registration and slot booking.
2. Medicines and pharmaceuticals.
3. Movement of essential goods.
4. Movement of medical emergencies
5. Persons travelling on Essential Government duty. V.i.Z
 - a. Medical Teams and Official on COVID-19 duty
 - b. Police security and Armed forces
 - c. Civil Defense and Home guards.
 - d. Fire & Emergency Services
 - e. Electricity
 - f. PHE
 - g. Public distribution system
 - h. PWD
 - i. Information and Public Relation
 - j. Telecommunication services
 - k. Print and electric media Petrol Pumps

- l. LPG distributors
- m. Farming activities in rural areas (Including betel nut and betel leaf)
- n. MGNREGA activities in rural areas
- o. Essential veterinary services including feed and fodder movement for livestock for farmers.


