



**ORDER**  
**(26.07.2021)**

No. EJHD/Con.11/2013/Pt.IV/44:In pursuance to order of Home (political) department No. POI.75/2020/Pt.I/ 106, dated 16<sup>th</sup> July 2021 and in continuation to this office order No. EJHD/ Con.11/2013/Pt.IV/34, dated **Khliehriat the 01.07.2021** and in order to safeguard from an uncontrollable surge in Covid-19 cases and to ensure essential commodities are available to the citizens in the notified markets. **Therefore all Essential shops and Non Essential shops shall be open on every ( Monday, Wednesday and Friday) in the major Market areas of Khliehriat East & West, whole of Ladrymbai, Umpleng Chiehruphi, Lumshnong, Sohkympkor, Sookilo, Saipung, Semasi, Jalaphet, Rymbai, Wapung, Sutnga, Bataw and Umkiang from 10.00 A.M to 5.00 P.M until further order and all locality shops to be strictly regulated by the Durbar Chnong/ Market Committee as indicated below.**

1. Inter District movement of persons is not permitted. No person is to step out without valid reason .
2. Vehicles without passes will be liable for strict penalties. Any one in defiance of orders is liable for arrest.
3. Standalone locality shops will be permitted to open from 2.00 P.M upto 6.00 P.M only with strict protocols / advisories and to be regulated by the Durbar Chnong/ VDPs.
4. In situ construction works for Government and private projects that do not involve movement of labour are permitted with due permission from this office.
5. Political, public social and religious gatherings including conferences, meetings and trainings wedding and sporting are not permitted.
6. Central Government Offices and State Government offices are permitted to function at 30 % strength. Essential department of the State Department shall function at strength as decided by the District head.
7. **All Post offices are permitted to open from Monday to Friday with limited staff and they shall close by 3.00 P.M.**
8. **All banks are permitted to open from Monday to Friday with limited staff and they shall close by 4 P.M.**
9. **Authorized Home delivery services** only will be permitted
10. Funeral gatherings should be restricted to 20 persons.
11. Opening of essential and non essential commercial establishments/ shops/ malls other economic activities is permitted on **every Monday, Wednesday and Friday.**
12. All shops are required to indicate status of their staff in their shop premises.
13. Saloons and Beauty parlours are permitted to open , subject to strict compliance to the protocols.
14. Offices of **schools** may be permitted to open three times a week at 30 % strength , with due permission from the office.
15. Non contact sports ( Archery, shooting, cycling, fencing and Athletics) semi – contact sports ( golf lawn tennis and Badminton ) as defined by sports and youth affairs department vide No. SYA.91/2020/1 dated 16.06.2020 are permitted, subject to adherence to Sops laid out in the aforesaid mentioned Notification and undertaking for strict compliance to protocols is to submitted to the office. Competitive games with spectator are not allowed.
16. Archery and Teer counters will be permitted on every **Monday , Wednesday and Friday** as per SOPs.
17. Gymnasium/ Yoga Insitutes/ Fitness centre are permitted to re-open as per protocols dated 1<sup>st</sup> March, 2021 issued by the Ministry of Health and Family Welfare.

**Exemptions:**

1. Health services including emergency services and vaccination. Person (s) moving for vaccination should be able to produce proof of COWIN registration and slot booking.
2. Medicines and pharmaceuticals.
3. Movement of essential goods.
4. Movement of medical emergencies
5. Persons travelling on Essential Government duty. V.i.Z
  - a. Medical Teams and Official on COVID-19 duty
  - b. Police security and Armed forces
  - c. Civil Defense and Home guards.
  - d. Fire & Emergency Services

- e. Electricity
- f. PHE
- g. Public distribution system
- h. PWD
- i. Information and Public Relation
- j. Telecommunication services
- k. Print and electric media Petrol Pum
- l. LPG distributors
- m. Farming activities in rural areas ( Including betel nut and betel leaf)
- n. MGNREGA activities in rural areas
- o. Essential veterinary services including feed and fodder movement for livestock for farmers.
