



ORDER
(18.08.2021)

No. EJHD/Con.11/2013/Pt.IV/70:In continuation to this office order No. EJHD/ Con.11/2013/Pt.IV/44 dated Khliehriat the 26.07. 2021 and in pursuance to Government order No. Pol.75/2020/Pt.I/109, dated Shillong the 13th August, 2021 and in order to safeguard from an uncontrollable surge in Covid-19 the following containment measures will be enforced w.e.f 18.08.2021 in the District.

1. Political , public and social gatherings are not permitted including conferences meetings and trainings.
2. Entry of tourist from outside the state shall not be permitted and all tourist spots shall remain closed.
3. Resumption of Commercial transportation may be permitted by the undersigned based on the local situation but not exceeding 30 % in urban areas and 50 % in rural areas.
4. Limited construction activities may be permitted by the undersigned based on the local situation.
5. Movement of skilled manpower for construction activities may be permitted by the undersigned based on the local situation.
6. International Border Trade shall be regulated by the undersigned.
7. Religious places / places of worship are permitted to re- open in the district subject to compliance with the Sop issued by the government . Solemnization of marriages in religious places/ places of worship shall be as per the SOP.
8. Funeral gathering to be restricted to 20 persons with prior intimation from the undersigned and there will be no procession to the Cemetery or Crematorium.
9. Engagement/ Marriages ceremonies outside religious places/ places of worship to be restricted to a total of 20 persons with prior permission from the undersigned.
10. Wedding reception is not permitted.


