



ORDER

No. EJHD/Con.11/2013/Pt.IV/90: In partial modification to this office Order No. EJHD/Con.11/2013/Pt.IV/76 dated the 24.08.2021 and in view of very low coverage of vaccination in the areas mentioned below and in pursuance to Government order No. POL.75/2020/Pt.I/112, dated Shilong the 27th August, 2021 and in order to safeguard from the uncontrollable surge of COVID-19 cases, the following arrangement has been made as indicated below w.e.f 6th September, 2021.

Opening of shops and markets

- a) **Opening of shops in the localities/ major Market areas of Chiehruphi , Lumshnong, Rymbai, Bataw , and Umkiang East Jaintia Hills District will be allowed to open on every Monday, Wednesday and Friday only from 9.00 A.M to 6.00 P.M.**
- b) **Reopening of restaurants and bars at maximum 50 % strength subject to compliance with the Sop.**

The shopkeepers and the public should strictly adhered to the following protocols while making their purchase

- a) Everyone should wear double mask (3 -ply plus cloth mask) or N—95 mask without fail.
- b) Social distancing of at least 2 meter should be strictly maintained by all.
- c) People are not permitted to loiter in the market area without any valid reasons.
- d) Anyone found violating protocols will be liable for shops- closure or fined.
- e) There shall be no overcrowding in one area/ shops and people should spend minimum time in the shops/Market area.

I. **Opening of offices and schools.**

- I. Central and State Government offices may function at 100 % strength and shall close at 5.00 P.M daily.
- II. Banks and Post Offices may function at 100 % strength subject to compliance with the Sops.


