**QUOTATION CALL NOTICE**

Sealed Quotations are invited from interested reputed Travel Agencies/Tour Operators/ private individuals for providing **one** number of Tiago/ Bolt/ Celerio (Petrol) car having sitting capacity not more than five including Driver, which shall conform to the Terms and conditions (Annexure-II) for official use in the Office of the Assistant Registrar of Cooperative Societies, Boudh on monthly rent basis.


1. The vehicle must be in Road worthy condition/ shall not be more than (03) three years old from the date of initial registration and must have valid Registration Certificate, Insurance Certificate, Fitness Certificate, Valid contact carriage permit, proof of up to date tax payment etc., which are mandatory for plying of vehicle.
2. The driver of the vehicle must have valid driving license for driving light transport passenger vehicle and should be sufficient experienced in driving transport passenger vehicle.
3. The driver should be well behaved, gentle and obedient in nature.
4. A sum of Rs 5000/- (Rupees five hundred) only shall be deposited by the intending bidders in shape of account payee Bank draft/ Bankers Cheque drawn in favour of the Assistant Registrar of Cooperative Societies, Boudh and submitted along with the tender as security deposit. After completion of Tender process the amount will be refunded to unsuccessful bidders.
5. The monthly rate of hire charges be quoted separately in the general bid information. (Excluding fuel and lubricants).
6. The vehicle must achieve fuel efficiencies of 17 Kms per litre.
7. The maximum hire charges per month excluding Petrol cost Rs 20,000/- (service Tax would be reimbursed separately over and above the hire charges)
8. The details of the make and year of manufacture of the vehicle, Registration Number, mileage (KMS covered per litre) and name of the driver with driving License No. and period of validity should be specifically provided in the general bid information to be furnished with Quotation (Annexure-III)
9. In view of pollution being high through use of Diesel Vehicles it is preferable to hire BS-IV compliant petrol vehicles (Finance Deptt. Notification No. 30464/f Dt. 06.09.2019 of Govt. Of Odisha)
10. The Quotation completed in all respect should reach the undersigned on or before **25.10.2019** by 2 PM and shall be opened on the **Dt. 26.10.2019 at 11 AM** in presence of the bidders or their authorised representatives.
11. The application form of Quotation containing general bid information and terms and conditions for hiring of vehicle etc. will be available in the Office of the ARCS, Boudh on payment of Rs 100/- by a demand draft towards the cost of application form from **17.10.2019** to **25.10.2019**.




